Product Declaration: EU REACH Regulation and SVHC

To Our Valued Customers,

REACH Regulation (EC) 1907/2006, Article 33 requires companies who supply products that contain more than 0.1% by weight of any REACH Candidate List Substance (SVHC) to provide their customers with "sufficient information, available to the supplier, to allow safe use of the article including, as a minimum, the name of that substance." As of the date of this letter, there are 209 substances included on the candidate list (SVHC).

To the best of our knowledge and with considerations to the latest candidate list and current information collect through our supply chain, most products provided and/or supplied by Vibra-TITE® Do Not contain any of the SVHC above the threshold concentrations. However, there are few exceptions: a limited number of products contain a SVHC as listed in the current version of the candidate list. Please refer to below table for products that contain SVHC material.
